

Fast-Growing Demand for Electricity

When the Rural Electric Cooperatives were first established, members were thrilled by the simple joy of illuminating their homes with a few light bulbs. As time has gone on, our lives have transformed dramatically, and the number of electrical devices in our homes has exploded beyond what we could have ever imagined. Across our service territory and throughout the United States, electricity consumption has surged. Households continuously demand more power, partly due to the abundance of electronic devices, while the expansion of data centers and large warehouse facilities has further increased the strain on our electrical systems as a whole. As the nation shifts its focus toward cleaner energy sources, traditional power generators, like coal and nuclear, have faced closures or extensive costs to follow new policies. Many of these reliable power sources are now in transition, grappling with the challenge of adopting greener technologies while still meeting the growing demand for electricity. With the rise of demand, comes the rise of costs for these sources to produce the necessary energy to supply all of us.

This rising demand for electricity, along with supply chain delays and escalating costs, it places us at a pivotal moment in energy management. As we navigate these challenges, our hope is to keep our members informed and educated on what is going on as well as how it may affect our membership and cooperative. Each element of this puzzle—whether it's heightened demand, changing energy policies, or supply constraints—affects the cost of providing safe and reliable electricity.
